The standard deduction has increased

MFJ = \$27,700 (\$1,800 up from last year)

HOH = \$20,800 (\$1,400 up from last year)

MFS or Single = \$13,850 (\$900 up from last year)

EARNED INCOME TAX CREDIT

For Tax Year 2023 maximum EITC amount is \$7,430 for qualifying taxpayers who have three or more qualifying children.

Tax Rates for 2023 are 12% for incomes over \$11,000 to 37% for incomes greater than \$578,125



VIRTUAL CURRENCY

Virtual currency is treated as property and general tax principles applicable to property transactions apply to transactions using virtual currency.

When you come to your tax appointment it is important that you have ALL the information required to complete your tax return.

All csvs files converted to pdf or excel that coincide with the income types that you had must be in our office prior or at the time of your tax appointment.

A Crytocurrency organizer will be provided to you. You can request it by email or thru the tax link.

- ✓ Form 1095-A (for health Insurance purchased through a public exchange)
- ✓ All 1098T (Tuition), 1098E (Student loan interest), 1098 (Mortgage payments)
- ✓ School or medical records for your dependents (must have address and name of dependent)
- ✓ Childcare provider payments (letterhead with name, address, EIN, phone of provider)
- ✓ ALL DOCUMENTS for events that happened to you in the current tax year
